612L Transmission Line Relocation Notice of application filing and approval

Thank you for your ongoing participation in the 612L Transmission Line Relocation. We submitted an application for the project to the Alberta Utilities Commission (AUC) on September 4, 2025. The Alberta Utilities Commission (AUC) approved this project for construction on September 10, 2025.

Next steps

Where construction activities are required to take place on private property, we will contact you in advance to discuss the specific dates and times we will require access to your property.

We plan to begin construction in October 2025 and anticipate construction to be complete in December 2025.

Depending on where you are in relation to the project, you may see or hear:

- noise and construction crews
- transmission structure construction
- wire stringing on the transmission structures
- salvage and reclamation of existing line and structures

AUC Approval

Project background

The proposed modifications are in two different locations in the area of the Hamlet of Grassy Lake:

- Approximately 800 metres (m) south of the Grassy Lake at Highway 877
- Approximately 10 kilometres west of Grassy Lake at Highway 3

The proposed modifications south of Grassy Lake include:

- replacing five wooden monopoles that are approximately 17 m tall with five wooden or steel monopoles that will be approximately 20 m tall

The proposed modification west of Grassy Lake include:

- relocating a portion of the 612L transmission line that crosses Highway 3 and the CPKC railway line
- salvaging the existing 612L alignment
- replacing wooden monopole and H-frame structures that are approximately 17-19 m tall with new wooden and steel monopole structures that will be approximately 20-23 m tall
- two of the new structures will require guy wires

We do not anticipate disruption to local distribution service as part of this project.
