Dear Ms. Kellgren:

**RE: AltaLink Management Ltd., in its capacity as general partner of AltaLink, L.P. (AltaLink),
KainaiLink and PiikaniLink 2024-2025 General Tariff Applications**

AltaLink is hereby filing with the Alberta Utilities Commission (the Commission) its General Tariff Application (GTA) along with the KainaiLink and PiikaniLink GTAs for the 2024-2025 Test Period commencing January 1, 2024, through to December 31, 2025.

These GTAs consists of the following:

1. The Application;
2. Appendices containing detailed supporting information, including evidence of independent witnesses; and
3. MFR schedules (in Excel format).

The GTA also includes AltaLink's Deferral Accounts Reconciliation for projects completed in 2021-2022 and amounts associated with other deferral accounts.

To assist the Commission, AltaLink has prepared a proposed process schedule for the Commission's consideration as follows.

AltaLink submits that the proposed schedule reflects appropriate process steps and reasonable timelines for each step, having regard for the size and complexity of the GTAs. In addition, AltaLink notes the following.

Prior to filing the GTAs, AltaLink met with customer groups to provide a high level overview of the GTAs. Based on those discussions, AltaLink understands that all parties are supportive of a procedural schedule that includes a Negotiated Settlement process. Pursuant to AUC Rule 018, Rules on Negotiated Settlements, AltaLink requests approval to initiate a Negotiated Settlement Process on all aspects of its GTA and the KainaiLink and PiikaniLink GTAs. AltaLink submits that including a negotiated settlement process in the proceeding schedule is consistent with the

Commission's efforts to reduce regulatory burden and improve the efficiency of the regulatory approval process.

In discussions with customers, AltaLink also proposed convening a technical session on AltaLink's cyber and asset security programs. Given the considerable risks posed by bad actors and the complicated and confidential nature of AltaLink's programs to combat these risks, AltaLink requests that the Commission include in the process schedule a confidential technical session to allow for an efficient exchange of relevant information between AltaLink and the Commission/interveners on this important topic. Specifically, a confidential technical session will allow the Commission, Commission staff and Interveners to ask questions of AltaLink and its experts to gain a more comprehensive understanding of the threats and risks to the Alberta Interconnected Electric System and AltaLink's Test Period programs designed to address those risks. Current and emerging threats to AltaLink's transmission infrastructure, if not properly addressed, could lead to devastating impacts for Alberta and its economy.

Further, AltaLink requests a technical session for salvage to provide an opportunity for the Commission, Commission staff and Interveners to explore and better understand the issue in a free-flowing and open manner. AltaLink anticipates much can be accomplished in a technical session with the hopes that salvage issues are minimized in the proceeding.

AltaLink submits that a more complete exchange of information through the proposed technical sessions will benefit both the Commission and interveners, will markedly improve the probability of AltaLink and interveners reaching a negotiated settlement of the GTAs, and will ultimately result in a more efficient regulatory approval process.

The proposed schedule reflects AltaLink's request that the Commission issue its decision on the GTAs no later than December 31, 2023 to provide certainty on rates prior to the commencement of the Test Period.
