# Notice of application filing

Thank you for your ongoing participation in the Kaybob South 3 Cogeneration Plant Connection. We submitted an application for the project to the Alberta Utilities Commission (AUC) on May 8, 2025.

#### **Project update**

In our January 2025 newsletter, AltaLink indicated that the new transmission line would connect from the Kaybob South 1117S substation to the existing Benbow 397S Substation. In fact, the new transmission line will connect the Kaybob South 1117S Substation to the existing 864L transmission line via a t-tap configuration immediately outside of the Benbow 397S Substation.

#### **Project background**



To connect Pembina Gas Infrastructure's (Pembina) Kaybob South 3 Cogeneration Plant to the grid, AltaLink is proposing changes to its transmission system. The project is located in Woodlands County and the M.D. of Greenview.

AltaLink is proposing to build a new transmission line and install a new telecommunications tower to connect Pembina's proposed Kaybob South 1117S Substation and cogeneration plant to the grid. The new transmission line is proposed approximately 35 kilometres south of Fox Creek and the new telecommunications tower is proposed approximately 15 kilometres southeast of Fox Creek.

To accommodate this connection, AltaLink's is proposing to:

- Construct approximately 650 metres of new 138 kilovolt (kV) transmission line to connect AltaLink's existing 864L Transmission Line, located in NE-15-59-18-W5, to Pembina's proposed Kaybob South 1117S Substation, located in SE-15-59-18-W5.
- Install a new telecommunications tower within AltaLink's existing Fox Creek 347S Substation, located in NE-34-61-18-W5.
